Notes:

- 1) Silver Warehouse Receipts #PR00201 through #PR05000 are reserved as proofs and have not been issued.
- 2) Silver Warehouse Receipts #SP05001 through #SP10000 are reserved as specimens, are not backed by silver, and not subject to audit.
- 3) Silver Warehouse Receipts #A010000 through #A017000 are reserved for special collector issues at a later date.
- 4) Silver Warehouse Receipts #D232501 through D232500 were destroyed in production.
- 5) Silver Warehouse Receipts #D235501 through D235500 were destroyed in production.
- 6) Gold Warehouse Receipts #PR00001 through #PR00012 are reserved as proofs and have not been issued.
- 7) Due to higher silver prices, the Face Value (FV) of the 500 ounce Digital Warehouse Receipt (DWR) has been revised from \$5,000 to \$10,000 as the Liberty Dollar moved up from the \$10 Silver Base to the \$20 Silver Base. As of November 24, 2005, all existing eLibertyDollar accounts were also doubled as twenty Liberty Dollars are now backed by one Troy ounce of .999 fine silver.
